 - Crutchfield on lot 6E in Carter Estates (framing completed, finishing exterior)
 - Sale on lot 126 (framing complete, finishing exterior)
 - LeBlanc on lot 118 (framing complete, finishing exterior)
 - Nagim on lot 120 (framing complete, finishing exterior)
 - Sunrise Homes plan approved and construction started on lots 228 & 229
 - Easley on lot 18 (lot cleared; plan approved, construction ready to start)
 - Lambert on lot 19 (lot cleared; plan approved, construction ready to start)
 - Mindrut on lot 104 (plan being reviewed)
- O Lot 49 Tantillo: removed trees, submitted plans, needs to return plans
- Lot 179 Peter Chan; reviewed preliminary plans; final not submitted
- o Lot 167 Met w/ McMorris; pad built-created drainage issues
- o Lot 184 Kingston; reviewed preliminary plans; not yet submitted (Monarch Point)
- Lot 208 Da.Gendusa plans submitted; review fee paid (no deposit)
- o Lot 58 Spurrier; plan submittal on hold
- Lot 170 Barrett Morgan, new property owner contacted us about building on water

Other development:

- River Lot Covenants generated w/ B.Waters Bulkhead & piling construction started with steel beam framing on six lots. Framing started on two. Prototype designs created, and three houses in design process.
- o Carter Reserve Two houses near completion; one house being framed and one plan approved

Lots owned/developed by Level Homes (70 lots)

- Completed 53 homes finished or occupied in since 2018.
- ➤ Have eleven homes in construction or plans submitted & ready to start.
 - 40 & 14A Near completion finishing interior
 - 59, 62, 262, 37 & 7A framed, starting to work on interior
 - 261 & 3A Just starting; slabs being framed
 - 219 & 61 Plans approved; not started
- ➤ 6 Un-developed lots: 3 in Tall Timbers; 3 on Cemetery Rd.
- In negotiation with owner to purchase nine lots in Tall Timbers
